

NOTICES TO MARINERS

FREE PORTS - AIDS TO NAVIGATION

To: All Vessels, Shipping Agents, Marine Services Provider and all other concerned parties

In order to enhance the safety of navigation within the Free Ports limits, the following changes for below Buoys and Beacons have been carried out:

A- The New Free Port

a) A new shore Light Beacon to mark the southern breakwater of the entrance to the New Free Port has been installed. The details of the new installed breakwater Light Beacon are as follows (see attached picture as an example):
